1 Background

This paper is a current NEHTA position on classification of Healthcare Providers Individuals and Organisations. It is based on the original Unique Healthcare Provider Identification Specialty/Type/Business Services Definitions and Standards, Discussion paper, Version 14 – 26/06/08, which was a subject of extensive external review. The document was distributed to the HPI key stakeholders, out of which 27 organisations responded with 237 comments in total. In some cases the written feedback was followed up by a teleconference to ensure complete understanding of the criticism or suggestions.

Current version also includes changes to the ANZSCO and ANZSIC for 2009 release and ABS feedback on code's extensions and description changes, made by NEHTA.

2 Purpose

The primary purpose of this document is to specify data attributes for healthcare providers that represent their professional characteristics or 'specialty' related data.

These attributes include:

- Provider type
- Specialty; and
- Provider business services

In the context of the HI Service, these attributes will be used for the purpose of:

- Unique identification of Healthcare Providers (both Provider Individuals and Provider Organisations)
- Support the Healthcare Provider Directory

The proposed classification for 'specialty' related attributes is based on existing Australian standards, which were extended or changed to fully satisfy the HI Service requirements and were advised by the healthcare community during the HI HPI Specialty Data Elements discussion paper review process.

Editorial note:

This document describes only those individual providers and organisations, which are directly involved in healthcare provision. Classification of non-healthcare organisations, or healthcare support organisations (e.g. IT technical support organisation or third party software vendor organisation), which will be a part of the HI Service community and act on behalf of healthcare organisations, are specified in a separate document.

2.1 Existing Provider Classification Standards

The review of the existing Australian standards identified that existing healthcare provider classifications have evolved to support traditional reporting needs and do not adequately address the requirements of unique identification or provider directory services.

These standards either do not have complete coverage (e.g., METeOR establishments mainly classify acute care organisations) or have inaccurate representation of the occupation (e.g. ANZSIC, the ABS classification on Professional Occupations does not reflect the recent changes in accreditation within General practice).

The proposed classification also adopts the model and business services related data domain values that are currently deployed by the existing commonwealth and jurisdictional directories as a strategy for standards' harmonisation and further development.


3 Background to the HPI

The ability to accurately identify healthcare providers, healthcare organisations and individuals who are interacting with the healthcare system, is critical to the delivery of seamless healthcare.

Consistent and unique identification will significantly reduce the possibility of information being sent to the wrong provider, or being assigned to the wrong patient.

In February 2006, NEHTA received funding to commence work on the development of national Healthcare Provider Identifiers (HPI) and specifically, an HPI for individual providers (HPI-I) and an HPI for provider organisations (HPI-O).

These identifiers represent two of the three identifiers supported by the Healthcare Identification Service (HI Service) – the third being the Individual Healthcare Identifier – and will uniquely identify healthcare providers, and (where required) their business entities and workplace locations.





This unique identification is essential for the secure exchange of patient information between authorised healthcare providers.

The HPI will use existing trusted data sources and national infrastructure where possible.

The benefits of uniquely identifying health care providers (individuals or organisations) are outlined in Australian Standard 4846 Health Care Provider Identification [AS 4846 -SA2006]:

- 1. Ability to confidently communicate with other health care providers for ongoing client care
- 2. Ability to verify information about individual providers with other data to identify or confirm their capabilities and qualifications (e.g. their specialty, registration with accredited bodies)
- 3. Ability to provide reliable information about services provided by individual health care providers to individual clients

- 4. Efficient and appropriate payments of fees, rebates etc. to providers
- 5. Less time wasted and inconvenience generated in searching for and/or re-gathering information
- 6. Less duplication of testing and prescribing.

These benefits translate to more efficient health care.

One objective of the HPI is to realise these benefits by defining data specifications that meet the needs of various business functions including:

- Referrals
- Discharge summaries
- Pathology reporting
- E-prescribing
- Identification and matching
- Provider Authentication and credentialing Provider directory services
- User management services.

4 Informational Requirements of the HPI

4.1 Overview

The intended primary purpose of the HPI is the accurate identification of healthcare providers and their respective organisations across all healthcare settings.

Accurate provider identification ensures that a healthcare individual's health information is accurately associated with the correct healthcare provider, and electronic and non-electronic communications occur between the correct providers.

The HI Services will provide a Healthcare Provider Directory (HPD) service to support information exchange for Healthcare Provider Individuals (HPI-I) and Organisations (HPI-O). Healthcare individuals or organisations (through their Organisational Maintenance Role) are able to elect whether or not to be listed in the HPD.

For healthcare provider individuals, the HPD will contain a subset of the HPI-I Record such as specialty, organisation affiliations and addressing information.

For any healthcare provider organisations, regardless of their structure and hierarchical position within complex organisations, the HPD will contain a subset of the HPI-O Record such as affiliated healthcare provider individuals, organisation services, and physical and electronic addressing details.

4.2 HI Service Business Scenarios

Appendix A provides a set of scenarios that illustrate the expected use of the HI Service specifically in terms of the HPI. These should be read in conjunction with the HI Service Concept of Operations.

4.3 Definitions

4.3.1 General

Healthcare Provider Individual

The HI business requirements define Healthcare Provider Individual as a person engaged in the direct provision of healthcare services to Healthcare Individuals [HI REQSPEC]. Following the consultation, the below definition was proposed:

• Any person who provides or is a potential provider of a health care service.

• An Individual Provider is an individual person and is not considered to be a group of providers. (ISO, Health Informatics — Provider Identification, 2008 draft.)

This definition is anticipated to be adopted in the new release of AS4846.

Healthcare Provider Individual Type

A broad classification of healthcare provider individuals engaged in the provision of healthcare services. [AS4846, ANZSCO 12200_2006].

Healthcare Provider Individual Specialty

The field that a healthcare provider individual identifies as being their field of practice i.e. the skill or knowledge in a particular area practised by that provider. [AS4846, ANZSCO 12200_2006].

For the purpose of Healthcare Provider Directory terms "Main Specialty or main Field of Practice may be used for those providers who have multiple specialisations.

Healthcare Provider Individual Specialisation

The lower level of specialty that a healthcare provider individual identifies as being their specialised field of practice i.e. the skill or knowledge in a more specific practised by that provider. [Based on AS4846].




Figure 2 - Healthcare Provider Individual's Record Structure

Healthcare Provider Organisation

A Healthcare Provider Organisation is an organisation that provides healthcare services¹ to prevent or cure disease, provide care for illness, impairment, disability or handicap, or non-healthcare goods and services to support these activities. HI business requirements define a Healthcare Provider Organisation

as any organisation that is directly involved in the provision of healthcare services to Healthcare Individuals [REQSPEC].

Healthcare Provider Organisation Type

The type of organisation that provides health care goods and services to prevent or cure disease, care for illness, impairment, disability or handicap, or non-health care goods and services to support these activities [METeOR].

Healthcare Provider Organisation Service Type

Organisation services are specialities provided by Healthcare Providers in private or group practices in their own offices (e.g., centres, clinics) or in the facilities of others, such as hospitals or health maintenance type medical centres [METeOR].

Healthcare Provider Organisation Services Units

The nature of service provided by an organisational unit or organisational arrangement, which a healthcare provider organisation provides [METeOR].

The following sections describe the different data elements associated to the Healthcare Provider Individual such as Healthcare Provider Type, Healthcare Provider Specialty and Healthcare Provider Specialisation.

4.3.2 Healthcare Organisation

<u>Policy</u>

Legislation² defines a Healthcare Provider Organisation as an entity that provides healthcare services³ to healthcare individuals.

The legislation⁴ also addresses those entities that are excluded from use or disclosure of healthcare identifiers as those engaged in underwriting a contract of insurance for a healthcare individual, determining eligibility for insurance or employing the healthcare individual.

Eligible healthcare provider organisations can be divided into two separate hierarchical types: 'Seed' Organisations, which may be defined as the parent or head organisation, and 'Networked' Organisations, which may be defined as an organisation/s falling under the leadership or direction of a Seed Organisation.

The HI Service Operator will seek applications from eligible⁵ healthcare organisations before an organisation can participate in the HI Service. The application will require the organisation's representative (e.g. Responsible Officer) to provide evidence of identity and evidence that the organisation meets the legislative requirements. Information regarding the rights and obligations of a healthcare provider organisation under the legislation will be made available through the Service Operator. At the completion of an application form a Healthcare Provider Organisations will be issued an HPI-O number and record.

A Healthcare Provider Organisation's representative will be required to give consent to have the organisations name and business contact details displayed in the Healthcare Provider Directory.

4.4 Healthcare Providers in the Context of the HI Service

This section was developed to define the different data elements associated to the HPI Specialty and their corresponding domain values with reference to current standards.

For **Healthcare Provider Individual specialty**, the referred standard is the Australian and New Zealand Standards Classification of Occupations (ANZSCO).

For **Healthcare Provider Organisation specialty**, the referred standard is the Australian and New Zealand Standards Industrial Classification (ANZSIC).

HPI-I Role is a term widely used in the health information community to specify low level permissions to access particular information that is stored in local systems within Healthcare Provider Organisation.

This is out of scope of the HI Service due to fluid nature of the Role concept and potential difficulties in maintaining and ensuring quality (accuracy and currency) of Role information on a national level.



Healthcare Provider Individual - Attributes and Domain Values



5.1 HPI-I Healthcare Provider Individual Type

5.1.1 Description

A broad classification of HPI-Is engaged in the provision of healthcare services.

5.1.2 Policy

The legislation⁶ states that a healthcare provider individual may be eligible to participate in the HI Service if they are registered by a registration authority as a member of a health profession (e.g. AHPRA) or they are a member of a professional association that has uniform national membership requirements and relates to the healthcare provided by its members.

Healthcare Provider Individuals who are not registered with AHPRA will be required to make application to participate in the HI Service. On completion of an application form a Healthcare Provider Individual will be issued an HPI-I number and record.

A healthcare provider individual will be required to give consent to have her/his name, professional and business contact details displayed in the Healthcare Provider Directory.

5.2 Non – HPI-I Healthcare Provider Types

5.2.1 Description

A group of providers that are involved in healthcare delivery, but will not qualify for HPI-I nor will this group have access to the Healthcare Provider Directory.

5.2.2 Policy

Individuals identified in this group do not satisfy all or some of the HPI-I selection criteria as defined in the legislation and outlined in Section 5.1.2 and on this basis are not considered to be healthcare providers eligible to participate in the HI Service in the same capacity as those defined under Section 5.1.

The legislation will allow access to the HI Service if the healthcare provider organisation, with whom they are employed or contracted, nominates a member of this group as requiring access to the Service as part of their duties. The healthcare organisation has an obligation to maintain current names and contact details for these nominated persons and to make this information available to the Service Operator. Only in these circumstances will some members of this group be able to access the HI Service using authorised credentials, provided through their organisation.

5.3 HPI-I Specialty

5.3.1 Description

The field that a healthcare provider individual identifies as being their field of practice i.e. the skill or knowledge in a particular area practised by that provider.

5.3.2 Policy

The legislation⁷ states that a healthcare provider individual may be eligible to participate in the HI Service if they are registered by a registration authority as a member of a health profession (e.g. AHPRA) or they are a member of a professional association that has uniform national membership requirements and relates to the healthcare provided by its members.

Healthcare Provider Individuals who are not registered with AHPRA will be required to make application to participate in the HI Service. On completion of an application form a Healthcare Provider Individual will be issued an HPI-I number and record.

A healthcare provider individual will be required to give consent to have her/his name, professional and business contact details displayed in the Healthcare Provider Directory.

5.4.5 Non - HPI-I Healthcare Provider Specialisations

5.4.6 Description

A group of providers that are involved in healthcare delivery, but will not qualify for HPI-I and are excluded from the Healthcare Provider Directory.

5.4.7 Policy

Providers in this category will be able to access the HI service where there is a business need by using suitable credentials provided through their healthcare provider organisation.

The legislation will allow access to the HI Service if the healthcare provider organisation, with whom they are employed or contracted, nominates a member of this group as requiring access to the Service as part of their duties. The healthcare organisation has an obligation to maintain current names and contact details for these nominated persons and to make this information available to the Service Operator. Only in these circumstances will some members of this group be able to access the HI Service using authorised credentials, provided through their organisation.

In addition, some members of this group will have already been assigned a HPI-I as a result of their registration and accreditation through AHPRA or their membership with an eligible professional association⁹ and application to the Service Operator.

Healthcare Provider Organisations - Attributes and Domain Values

The following sections describe the different data elements associated to the Healthcare Provider Organisation specialty.



6.1 Healthcare Provider Organisation Type

6.1.1 Definition

The type of organisation that provides health care goods and services to prevent or cure disease, care for illness, impairment, disability or handicap, or non-health care goods and services to support these activities.

6.1.2 Policy

Healthcare Provider Organisations can be an entity or establishment that is directly involved in providing health related services for Healthcare Individuals (e.g. hospitals, GP Practices).

Legislation¹⁰ defines a Healthcare Provider Organisation as an entity that provides healthcare services¹¹ to healthcare individuals.

Eligible healthcare provider organisations can be divided into two separate hierarchical types: 'Seed' Organisations, which may be defined as the parent or head organisation, and 'Networked' Organisations, which may be defined

as an organisation/s falling under the leadership or direction of a Seed Organisation.

The HI Service Operator will seek applications from eligible¹² healthcare organisations before an organisation can participate in the HI Service. The application will require the organisation's representative (e.g. Responsible Officer) to provide evidence of identity and evidence that the organisation meets the legislative requirements. Information regarding the rights and obligations of a healthcare provider organisation under the legislation will be made available through the Service Operator. At the completion of an application form a Healthcare Provider Organisations will be issued an HPI-O number and record.

A Healthcare Provider Organisation's representative will be required to give consent to have the organisations name and business contact details displayed in the Healthcare Provider Directory.

6.1.5 Exclusions

The legislation¹³ underpinning the HI Service addresses those entities that are excluded from use or disclosure of healthcare identifiers as those engaged in underwriting a contract of insurance for a healthcare individual, determining eligibility for insurance or employing the healthcare individual.

The following organisation types are excluded from the Healthcare Provider Organisation group and will not be eligible to be allocated an HPI-O:

- Universities
- Other Secondary/non-Health Care Services Organisations
- Call Centres
- Jurisdictional Provider Directories
- Provider Local Indexes
- Private Health Insurance Organisations

For this reason, these organisations are classified as non-healthcare organisations.

6.2 Healthcare Provider Organisation Services Type

6.2.1 Description

Organisation services are specialities provided by Healthcare Providers in private or group practices in their own offices (e.g. GP centres, clinics) or in the facilities of others, such as hospitals or health maintenance type medical centres.

6.2.2 Policy

The Healthcare Provider Organisation Type will specify the type of services. Legislation¹⁴ defines a Healthcare Provider Organisation as an entity that provides healthcare services¹⁵ to healthcare individuals (e.g. hospitals, GP Practices). These organisations will be assigned a HPI-O and with their consent will be listed in the Healthcare Provider Directory by the HI Service Operator.

The Healthcare Provider Organisation may provide a broad range of services which include healthcare, social welfare and human services¹⁶. Some parts of some healthcare organisations therefore may not be eligible to become a networked organisation as the current scope will only cover organisations providing direct healthcare services.

6.3 Healthcare Provider Organisation Service Units

6.3.1 Description

The nature of the services provided by an organisational unit or organisational arrangement, on behalf of a healthcare provider organisation, in accordance with the legislation.

6.3.2 Policy

The orchestration of the Services Units and granularity level of the service representation are based on the system's requirement, which is enabling the authorised HI User to find a particular healthcare service in the Healthcare Provider Directory.

It is possible that a provider specialisation, which is searched on, does not exist and only the use of a service description will enable the user to find a particular service provider.

Few principles were applied to the current classification:

• The HI service units classification is agnostic to the notion of target recipient of the service - e.g. pregnant women, men in high risk occupations)

- The HI service units classification is provider agnostic the service can be performed by any provider if that provider is professionally credentialed to provide the designated service - e.g. Immunisation can be performed in multiple healthcare settings
- The HI service units classification is agnostic to the location of the service location is architected under the concept of "networked HPI-O" within HPI-O model
- The HI service units classification does not cover "Service package," which consists of multiple services for example, coordinated care of a patient with complex needs, involving case conferencing.

6.3.4 Notes

All service units' codes are based on the existing ANZSIC codes. The codes descriptions are taken from VIC DHS PCP Directory and NSW HERO Services. NEHTA recognises ANZSIC's codes' limitations. NEHTA's vision is to use SNOMED terminology for the specification of healthcare services. The following classification will serve as a foundation for the SNOMED development work.

Appendix A Scenarios

A.1 Create HPI-I

A new graduate, Ms Script, has finished her pharmacy degree and secured a job offer from a chemist after completing her supervised practice in the pharmacy. However, before she can practice, Ms Script is required to register with the Australian Health Practitioners Regulation Agency (AHPRA)¹⁷.

Ms Script supplies AHPRA with the documentation required to support her registration as a practicing pharmacist.

As Ms Script does not currently have an HPI-I, she also requests allocation of a new HPI-I and to allow participation in the HI Services.

On processing the successful registration the Pharmacy Board (as a Trusted Data Source for the HPI Service) confirms that she does not currently have an HPI-I allocated and then sends a request together with Ms Script's information from the pharmacy board's records to the HI Service. This information includes her specialty.

The HI Service allocates a new HPI-I for Ms Script and associates her registration as a practicing pharmacist with it. The HI Service also records that the Trusted Data Source for this registration is AHPRA.

This initiates the creation of a new HPI-I and associated record in the HI Provider Directory for a registered practising pharmacist.

A.2 Create seed HPI-O

Mr Manager is a senior manager and part owner of the Sunwest Medical Services Group. The management committee determine that the Hospital will participate in the HI Service and Mr Manager takes on the task of setting it up.

After some initial investigation, Mr Manager collects documentation to support registration of Sunwest in the HI Service.

That documentation includes:

- A registration request for the Hospital that provides the required information
- Certificate of registration for the business
- Letter advising that Mr Manager is authorised to act on behalf of the Hospital; and

• Evidence of his identity

After collecting this documentation, he attends the HI Service Operator's business office to register the hospital.

The HI Service Operator asks Mr Manager for the required documentation and records that it has been sighted. The documentation is returned to Mr Manager.

The HI Service Operator registers the information of the organisation i.e. organisation type, name, address, electronic contact details and Mr Manager's details as the Responsible Officer for Sunwest in the HPI Service.

A 'seed' HPI-O is then created for Sunwest using the supplied registration information.

The HI Service Operator informs Mr Manager of the allocated HPI-O and provides him with log-in information for the HI Service.

As Mr Manager has indicated that Sunwest wishes its information made available in the HI PDS, the HI Service adds the directory specific information provided by Sunwest to the HI PDS.

For ongoing maintenance of the information held in the HI Service about Sunwest, Mr Manager nominates that Mr Clerk will be assigned the Organisation Maintenance Role (OMR) for the seed HPI-O. The HI Service updates the seed HPI-O record with Mr Clerk's details as the OMR and provides him with logon information.

A.3 Create a networked HPI-O for a department

The Sunwest Medical Services Group owns the Sunwest Respiratory Clinics. These are two clinics located for patient convenience in the Eastern and the Western suburbs respectively.

They provide consultative, diagnostic and ongoing care for chronic respiratory problems in children. They employ a number of medical staff and have arrangement with independent medical specialists who use their consulting rooms and treatment facilities.

To support direct referral of patients by GPs and other clinicians refer patients to this clinic, Sunwest wants the Respiratory Clinics to have their own HPI-Os.

As the Clinics are part of Sunwest Medical Services Group, Mr Clerk is able to create 'network' HPI-Os for each clinic without providing documentation to the HI Service (as was the case for the seed HPI-O).

These new HPI-Os, and any other network HPI-Os created by Sunwest Group will be organised into an HPI-O hierarchy with the Sunwest Medical Services Group's (seed) HPI-O at the top.

Mr Clerk, the OMR for the Sunwest Medical Services Group uses his HI Service login information to access the HI Service and selects the action of create network HPI-O.

The HI Service displays the current Sunwest HPI-O structure from which Mr Manager selects an existing HPI-O¹⁸ for which he has authority to create network HPI-Os – in this case, the seed HPI-O for the Sunwest Group.

He enters information for the Eastern Suburbs Respiratory Clinic which includes:

- Organisation type
- Name "Sunwest Respiratory Clinic"
- Address
- Electronic contact details
- Services

The HI Service allocates a new (network) HPI-O for the clinic and sets the seed HPI-O of Sunwest Medical Services Group as its parent. An updated organisation map is now displayed for Mr Clerk.

Mr Clerk now repeats this process for the Western Suburbs Respiratory Clinic – noting that he leaves the name of both clinics the same.

As the Respiratory Clinics are managed as a self contained business, Mr Clerk determines that day-to-day changes to information stored in the HI Service about them should be maintained by Mr Smith who works in an administrative capacity for the Respiratory Clinics.

As Mr Clerk was given privilege to establish new OMOs, he logs into the HI Service and sets up Mr Smith as a new OMR with authority to maintain information about both clinics. He does not however give Mr Smith authority to create additional OMOs or HPI-Os.

Because Sunwest want the Respiratory Clinics to be locatable in the HPD by other healthcare professionals who may want to refer clients to either of them, Mr Clerk selected the option to display the Respiratory Clinics in the HPD – which the HI Service does.

A.4 Create HPI-I and HPI-O relationship

The senior clinician for the Sunwest Respiratory Clinics is Mister Breatheasy who is an internationally published specialist in early childhood respiratory disease. He works Mondays in the Eastern Suburbs Clinic, Tuesday &

Wednesday in the Western Suburbs Clinic and keeps Thursday & Friday flexible.

In addition to working with Sunwest, he has arrangements as a VMO with a number of public hospitals.

Sunwest recognise that GPs and other specialists will want to refer patients directly to Mister Breatheasy and want to set up the clinics as a point of referral for him.

After gaining Mister Breatheasy's agreement, Mr Smith, in his capacity as OMO sets up linkages for the HPD between the HPI-Os for the two clinics and Mister Breatheasy's HPI-I.

A.5 Maintain HPI-I Record through AHPRA as TDS

A year after obtaining registration with the Pharmacy Registration Board, Ms Script marries her partner, Mr Repeat and decides to also change her name to Mrs Repeat-Script.

She notifies the Australian Healthcare Practitioner Regulation Agency (AHPRA) of her change of details and provides supporting evidence.

AHPRA updates her registration details and, as part of the ongoing synchronisation of AHPRA registration information with information held in the HI Service, the updated information is automatically applied to her registration information in the HI Service.

A.6 Lookup provider individual in the HI Provider Directory

Dr Health, a GP receives a new patient, Johnny Citizen who is accompanied by his mother - Mrs Citizen. Johnny has a history of Asthma that has been managed successfully to now however more recently his condition has worsened and Mrs Citizen wants someone to review his condition. After conducting his own preliminary assessment, Dr Health decides to refer Johnny to a respiratory specialist.

Mrs Citizen informs him that Johnny had seen Mister Breatheasy a few years back and that she would like to take Johnny back to him if possible.

Dr Health is aware of Mister Breatheasy however is not aware of his current contact details. He accesses the Healthcare Provider Directory and looks up Mister Breatheasy's contact details, using his name and specialty.

The HI Service locates the HPI-I information for Mister Breatheasy and uses the links in the HPD to display the two consulting rooms that Mister Breatheasy has agreed to have linked to his HPI-I. One of these is in the Eastern Suburbs and is most convenient for Mrs Citizen - Dr Health uses the HPD to obtain Mister Breatheasy's Eastern Suburb address and electronic contact details, and using this information, sends a referral for Johnny Citizen (which includes his IHI along with the Dr Health's HPI-I and the GP Practices HPI-O) to him. Dr Health also provides Mrs Citizen with the contact details for Mister Breatheasy's Eastern Suburbs Consulting rooms, so that she can make an appointment.

A.7 Lookup Provider Organisation in the HI Provider Directory

Mr Resident had a stroke and is now paralysed down the left side of his body. His neurologist, Dr Smith, advises Mr Resident's son, John, that his father will need to undergo physiotherapy if he is to regain some mobility in the left side of his body.

Dr Smith is affiliated with South Hospital, which provides physiotherapy services so recommends that Mr Resident attend that facility.

The Physiotherapy unit has recently relocated and as Dr Smith does not have their current contact details, he accesses the Healthcare Provider Directory and looks up the contact details, using organisation name and services to validate.

The HI Service retrieves the appropriate information. Dr Smith obtains the contact details and writes a referral (with Mr Resident's IHI) so that John can make an appointment on behalf of his father.

Editorial note: HI Scenarios in the Context of E-Referrals and E-Discharge Summaries

These scenarios were added to demonstrate how the HI Services can add value to the enhancement of a continuity and quality of healthcare delivery and was advised during the initial Jurisdictional review of the HI classification paper.

A.8 Selecting One of Many Providers (ereferral)

Mr John Paine has had trouble with his knees for years, worsening recently. His GP, Dr William Moore, diagnoses osteoarthritis, and recommends referral to an orthopaedic surgeon for consideration of a knee replacement. The surgeon to whom Dr Moore normally refers has retired.

Dr Moore uses a provider search form in his clinical software to search for providers with specialty "Orthopaedic Surgery" in or near Mr Paine's suburb. This local software finds no conveniently located orthopaedic surgeon so, as it has an interface with the Healthcare Provider Directory via web services, it uses this interface to access and search the HPD.

The HI Service locates several Orthopaedic surgeons in the general area. Dr Moore's medical software enhances the results with geographic coordinate information that allows the potential referees to be ranked by their distance from Mr Paine's home.

Dr Moore picks the closest one, Dr Jill Sarbanes, and his system records the corresponding HPI-I and HPI-O details as well as address for electronic referrals. Dr Moore sends a referral to Dr Sarbanes, who accepts the referral. Mr Paine contacts Dr Sarbanes' office to book an appointment.

Dr Sarbanes information is added to Dr Moore's local provider directory and linked to the referral.

A.9 An Emergency Referral to a Networked Organisation for a Particular Service

Joe Cramp goes to his GP, Dr Sally Forth, with a history of intense tightness in his chest and shortness of breath periodically over the past few days. After taking this history, Dr Forth worries that Mr Cramp is experiencing acute coronary syndrome, and calls an ambulance to take Mr Cramp to the nearest ED, at St Somewhere Hospital.

While waiting for the ambulance, she types a brief referral to the Admitting Officer at St Somewhere, and her software automatically populates the referral with a summary of Mr Cramp's medical history and current medications.

Her software has an electronic interface to the HI PDS and presents a provider search form.

Using this form, she looks up the Emergency Department at St Somewhere. To support this sort of enquiry, St Somewhere have created a `network' HPI-O for the Emergency Department and in this have provided the physical and electronic contact details for the ED.

Using this information, she prepares and send and electronic referral to the electronic address and prints a copy of the referral including the physical address of the Emergency Department which she gives to Joe Cramp.

At St Somewhere, the ED computer system receives the electronic referral and automatically forwards it to Dr Abody who is acting in the role of the Admitting Officer and performing admission services this day.

He receives the referral and notifies the triage nurse that Mr Cramp is coming. Having reviewed the notes in the referral, he asks that Joe Cramp have his electrocardiogram done as soon as he arrives.

Twenty minutes later, Joe Cramp arrives at the ED and presents his Medicare Card. The ED System uses his Medicare number to locate his IHI that is then matched to the referral and the request for an immediate electrocardiogram.

A.10 Lookups for Incompletely Specified Providers (Discharge Summary)

Ms Anna Patient is visiting Sydney from Queensland, when she develops severe abdominal pain and goes to a nearby emergency department without a referral.

She cannot remember all her GP's details, and tells the registration clerk that her GP is "Dr Jane," Family name unknown, at the medical centre on Bright St, Sunwest Bay. As the hospital's registration system has an electronic interface to the HI PDS, it is able to use this partial information to search for the GP.

The HPD returns two different GPs at different medical centres on Bright St.

The ED clerk reads these out to the patient who recognises one of the GPs (Dr Jane Good). The clerk selects this provider and her corresponding HPI-I and HPI-O information is stored by the registration system.

Ms Patient is assessed, diagnosed with appendicitis, and is admitted for an emergency appendectomy, which goes well. Ms Patient's Sydney friends offer to look after her for a week or two after discharge. So that Ms Patient can be monitored after discharge, they suggest that she go to their local GP who works out of the Convenient Medical Centre in Harbourview.

The hospital's discharge system is also linked to the HPD by web services.

As part of the discharge process, the resident confirms the GP for discharge – at this time, Ms Patient advises that she will be extending her stay in Sydney and would like to use the Convenient Medical Centre in Harbourview.

The resident uses their discharge system to locate the Convenient Medical Centre in the HPD and retrieves the electronic and physical address information for the Convenient Medical Centre and, using linkage information that the Medical Centre has set up in the HPD, gets the name and contact details for the Centre's senior GP.

The resident updates Ms Patient's discharge information in the medical record to the GP at the Convenient Medical Centre and prepares and sends a Discharge Summary to the Convenient Medical Centre with a copy to Dr Jane Good containing a recommendation that a GP review Ms Patient and remove her sutures in about a week.

When Dr Jane Good's medical software receives the electronic referral, it uses the IHI contained in it to add the information about the appendectomy to Ms Patient's medical record.

When the Discharge Summary is received at the Convenient Medical Centre, the practice software uses the information contained to create a new patient record for Ms Patient and stores the information about the recent appendectomy.
